## I. SPECIAL CONDITIONS

<b>Organiser:</b>	The promotion is organised and operated by <b>iWelcome2 Tourinform Limited (Kft)</b> (registered office: 1061 Budapest, Andrásy út 33.; company registration: Cg.[13 09 192961]; tax id: [25838486-2-13]; hereinafter: <b>iWelcome2</b> ).
<b>Prize offered by:</b>	<b>iWelcome2</b>
<b>Competition promotion regulated by these Terms and Conditions:</b>	<b>“MAKE A SPLASH!”</b> creativity-based, free-to-enter Competition Promotion (hereinafter: the <b>“Competition Promotion”</b> ).
<b>Purpose of the Competition Promotion:</b>	The purpose of the Competition Promotion is to promote the services of iWelcome2 as widely as possible to the participants in the Competition Promotion, with the help of the participants in the Competition Promotion.
<b>These Terms and Conditions will be published on:</b>	The website at [ <a href="http://iwelcome2.hu/">http://iwelcome2.hu/</a> ] and on the Facebook page of iWelcome2 [https://www.facebook.com/iWelcome2/] (hereinafter: the <b>“Web Sites”</b> ).
<b>Duration of the Competition Promotion:</b>	18 March 2019 to 23 May 2019
<b>Winners announced on:</b>	22 May 2019
<b>Conditions of entry:</b>	<p>Anyone can enter the Competition Promotion as a contestant (hereinafter: a <b>“Contestant”</b>) provided that they produce at least one photo or video, which they upload to at least one social media platform (hereinafter: an <b>“Approved Platform”</b>) and use the #iwelcome2 and #makeasplash hash tags. Accepting the conditions of entry detailed in these Terms and Conditions is a prerequisite of participation:</p> <ul style="list-style-type: none"> <li>a) the Competition Promotion is open to over-18s who have a profile on at least one of the Approved Platforms;</li> <li>b) participation in the Competition Promotion is voluntary and free of charge;</li> <li>c) Contestants must hold valid personal id documents or a passport;</li> <li>d) Contestants will be contacted in person after the prize draw in order to arrange collection of the Prize;</li> <li>e) Contestants must register for the Competition Promotion as per the General Conditions below;</li> <li>f) iWelcome2 may publish the name of Contestants on its Facebook page when announcing the winners.</li> </ul> <p>Data to be provided during registration: full name, email address, nationality, links of accounts registered on Approved Platforms. The Approved Platforms are Facebook, Twitter, Instagram and YouTube. The Competition Promotion is open to Contestants from any country.</p>

	<p>Restriction on photo and video entries: the content uploaded may not be in violation with the Terms of Use, Terms of Service, ethical and other policies of the Approved Platforms.</p>
<b>Prize:</b>	<p>The ten Contestants who receive the largest number of votes will receive a travel experience to Budapest, and will be entered into the competition organised by iWelcome2 in Budapest. The grand prize of this latter competition is a round-the-world trip (hereinafter: the “<b>Prize</b>”). The Budapest travel experience includes accommodation, food and drink, and sightseeing in Budapest.</p> <p>iWelcome2 reserves the right to announce more than ten Winners.</p> <p>iWelcome2 also reserves the right to change the contents and schedule of programmes included in the Prize. iWelcome2 will accept no liability in this regard.</p> <p>By accepting these Terms and Conditions and collecting the Prize, the Winner assumes an obligation of participating in the competition promotion on the same subject in Budapest. Should the Winner violate this obligation, iWelcome2 may lawfully refuse to provide the full accommodation to them.</p>
<b>Selecting and contacting winners and runners-up, collecting the prize:</b>	<p>The winners and runners-up, i.e. the Contestants who receive the largest number of votes, will be announced on iWelcome2’s Facebook page.</p> <p><u>Announcing winners and runners-up:</u></p> <p>The Competition Promotion will be open to Contestants between 18 March 2019 and 25 April 2019. At any time over this period, they may enter by using the #iwelcome2 and #makeasplash hash tags. By entering the Competition Promotion, Contestants accept these Terms and Conditions, with special regard to the conditions of entry.</p> <p>The Winners will be those Contestants who receive the largest number of votes for any of their photos or videos uploaded onto an Approved Platform. Voting will be done by means of likes, i.e. each like counts as one vote.</p> <p>Each Contestant has an equal chance of winning the Prize. This statement does not wholly apply to Contestants who upload the same photo or video to several Approved Platforms and to those whose large group of friends and acquaintances cast votes for their photos or videos, because these Contestants will have an advantage over those who have a smaller or no such group.</p> <p>Due to the nature of the Competition Promotion, the creativity of each Contestant will also be a factor in determining the winners and runners-up.</p> <p>Should a winner not claim their Prize within 48 hours of the announcement, they will lose the Prize and iWelcome2 will notify the runner-up who had the second most votes, who will also have 48 hours to claim the Prize. Should none of the runners-up claim the Prize, then the Prize will be retained.</p> <p>iWelcome2 reserves the right to use Contestants’ valid personal id documents or passport to verify their identity as the winner or one of the runners-up, when the Prize is collected.</p>

## II. GENERAL CONDITIONS

These General Conditions constitute the rules of participating in the Competition Promotion the duration and terms of which are detailed in the Special Conditions. The Competition Promotion is regulated solely by these Terms and Conditions. By participating in the Competition Promotion, Contestants accept and agree to these Terms and Conditions. The Terms and Conditions are published as described in the Special Conditions.

### 1. RULES OF ENTRY:

- 1.1. The Competition Promotion is open to over-18s from any country. Entry is through creating and uploading to an Approved Platform at least one creative photo or video, using the #iwelcome2 and #makeasplash hash tags to accompany the video. Accepting the rules of entry detailed in these Terms and Conditions is a prerequisite of participation.
- 1.2. Each Contestant may enter one or more photos or videos.
- 1.3. iWelcome2 accepts no liability for the availability of the Approved Platforms.
- 1.4. Compliance with the conditions of entry specified in the Special Conditions of these Terms and Conditions is a prerequisite of participating in the Competition Promotion.
- 1.5. Acceptance of these Terms and Conditions is a prerequisite of entering the Competition Promotion. By registering and entering the Competition Promotion, Contestants explicitly accept and agree to these Terms and Conditions.
- 1.6. Members, executives and employees of iWelcome2, as well their close relatives, as defined in Article 8:1 Section (1) of Act V (2013) on the Hungarian Civil Code, may not enter the Competition Promotion.

### 2. DURATION OF THE COMPETITION:

- 2.1. The Competition Promotion lasts for the period specified in the Special Conditions.

### 3. FAIR COMPETITION:

- 3.1. By entering the Competition Promotion, Contestants accept that iWelcome2 may, at any time and without advance warning, exclude from the Competition Promotion any Contestants who do not fully satisfy these Terms and Conditions. Exclusion from the Competition Promotion renders the entry invalid and removes the Contestant from the pool of potential winners.
- 3.2. iWelcome2 reserves the right to exclude any Contestants, at any time and without advance warning, who unfairly influence or attempt to unfairly influence the outcome of the Competition Promotion (including especially those who interfere with other entries or jeopardise the fairness of the competition in any way). Exclusion from the Competition Promotion renders the entry invalid and removes the Contestant from the pool of potential winners.
- 3.3. iWelcome2 reserves the right to ban from any future competition organised by iWelcome2 any Contestants who can reasonably be suspected of having committed a criminal offence in connection with their participation in the Competition Promotion, as well as any Contestants who can reasonably be suspected of unfair competition (such as obtaining likes through registering multiple accounts or using bots). Exclusion from the Competition Promotion renders the entry invalid and removes the Contestant from the pool of potential winners.

- 3.4. Contestants accept that if it is revealed after the collection of the Prize that their entry was illegal or in breach of these Terms and Conditions, they must return the Prize and offer compensation for any damages arising from their illegal actions.

#### **4. SELECTING THE WINNERS AND RUNNERS-UP:**

- 4.1. The winner and runner-up will be selected through the announcement described in the Special Conditions, made at the time specified in the same.
- 4.2. In order to enter the weekly prize draws specified in the Special Conditions, Contestants must join the Competition Promotion by 11:59 pm on the day before the announcement is made.
- 4.3. The winner/runners-up will receive an email notification from iWelcome2 following the announcement as described in the Special Conditions. The winner must claim their Prize within 48 hours of being notified by iWelcome2, by sending a copy of their personal id document or passport to [hello@iwelcome2.com](mailto:hello@iwelcome2.com) and including a message stating that they accept the Prize. Should the winner (i) fail to claim the Prize within 48 hours of the notification; or (ii) refuse to provide the personal data required to verify their claim to the Prize; or (iii) is for whatever reason not eligible to claim the Prize, then the winner will lose their claim to the Prize. iWelcome2 will replace any such ineligible winner by announcing a runner-up in the same way as a winner is announced. iWelcome2 will then notify the runner-up as per the above, inviting them to claim the Prize.
- 4.4. iWelcome2 will accept no representations or complaints from the winner and runners-up if they lose their claim to the Prize because they could not be contacted.

#### **5. THE PRIZE:**

- 5.1. The winner/runner-up selected as per Section 4 of these Terms and Conditions will be entitled to the Prize specified in the Special Conditions.
- 5.2. By accepting the Prize, the winner/runner-up consents to the personal data contained in the identification documents they provided being verified by iWelcome2 to check eligibility.
- 5.3. The winner/runner-up may waive their claim to the Prize. In this eventuality, iWelcome2 will announce the runner up receiving the next most votes as the Winner.
- 5.4. The dates of the Budapest travel experience (i.e. the Prize) cannot be changed. iWelcome2 will accept no damages claims if the winner/runner-up is not able to use the whole term of the Prize (e.g. because they miss their inbound or return flight).

#### **6. DATA PROTECTION:**

- 7.3. iWelcome 2, acting as the organiser and operator of the Competition Promotion, disclaims all liability for external attacks against the web sites, online platforms and servers that are associated with the Approved Platforms.
- 7.4. iWelcome2, acting as the organiser and operator of the Competition Promotion, disclaims all liability for damages and compensation for any delays or associated costs, damages and losses arising during the Competition Promotion from any faults, malfunctioning and unavailability of the Approved Platforms.
- 7.5. iWelcome2 reserves the right unilaterally to expand or amend these Terms and Conditions. Any such amendments of these Terms and Conditions will be announced on the Web Site by iWelcome2, no later than 1 (one) day before their effective date.
